

NOTICE OF DATA EVENT

Galliker's Dairy Company ("Galliker's") is providing notice of a recent data privacy event that may affect information related to certain current and former employees, and their dependents. Confidentiality, privacy, and security of information is one of Galliker's highest priorities, and it takes this matter seriously.

On June 23, 2024, Galliker's became aware of suspicious activity on our third-party hosted, cloud-based environment. Galliker's took steps to secure the environment and launched an investigation to determine the nature and scope of the activity. Through its investigation, Galliker's learned that between June 23, 2024 and June 24, 2024, an unauthorized actor potentially accessed certain systems within the cloud-based environment, and downloaded files from those systems. Galliker's then began the extensive process of reviewing the files in the relevant systems, and learned they included information related to current and former employees, and their dependents. Although Galliker's has no evidence of any identity theft or fraud in connection with this incident, out of an abundance of caution, it is notifying those whose information was present within the systems.

While the information impacted varies by individual, the types of information that could have been impacted includes: Social Security number, driver's license number, financial account information, medical information, health insurance information, and username and password. At this time, there is no evidence of any identity theft or fraud occurring as the result of this incident.

Galliker's is providing notice and complimentary access to credit monitoring and identity restoration services to individuals whose information was affected in this incident. Galliker's encourages impacted individuals to remain vigilant against incidents of identity theft and fraud, to review account statements, and to monitor their credit reports for suspicious activity and to detect errors. Galliker's is providing impacted individuals with contact information for the three major credit reporting agencies, as well as providing advice on how to obtain free credit reports and how to place fraud alerts and security freezes on their credit files.
